

43rd Annual Transit Supervisors Organization Scholarship Awards

Dear Brothers and Sisters:

I am proud to announce that our partner M³ Technology will continue their commitment to sponsor five (5) one thousand dollar scholarship awards for 2024. I am also happy to announce that Pasternack Tilker Ziegler Walsh Stanton & Romano LLP will sponsor one (1) and Central Medical Services of Westrock have also agreed to continue their support and will sponsor two (2) one thousand dollar scholarship awards for 2024. This will be in addition to the three (3) one thousand dollar scholarship awarded by the Union. There will be a total of eleven (11) one thousand dollar scholarships awarded for the 2024 school year.

All scholarship winners and alternates will be drawn at a virtual scholarship awards ceremony on December 28st at 12:30PM. There will be eleven (11) winners and ten (11) alternates drawn on that day.

Eligibility

- Scholarship Awards are open to all Transit Supervisor Organization members in good standing, their spouses, and legally dependent children.
- Scholarship Awards are open to high school students who will be enrolled in an accredited college or institution **including Trade School** in the 2024 school year, college students, and TWU Local 106 members enrolled in an accredited college or **Trade School** in the 2024 school year.
- In order to receive the Scholarship Award, spouses and legally dependent children must be registered as full-time students (enrolled for at least 12 credits). Active members can be either full or part-time students.

Only Transit Supervisor Organization members in good standing can sign the Application Form.

Disbursement of Scholarship Award

Scholarship Award winners, at the time of enrolling in an accredited college or **Trade School**, should inform the college/ **Trade School** that an official letter from the college/ **Trade School** verifying their enrollment must be forwarded to Transit Supervisors Organization at 5768 Mosholu Avenue, Bronx, NY 10471. Upon receipt and verification of such letter, The Transit Supervisors Organization will forward to the college/ **Trade School** the proceeds of the scholarship award.

Winners must use the proceeds of the award for qualified educational expenses during the 2024 calendar year. If the winner fails to use the proceeds in the specified time period, the award will be forfeited and awarded to the next alternate.

Members must be in good standing when the scholarship award is disbursed. The scholarship proceeds may be used only for tuition, college/ **Trade School** fees, or room and board while attending an accredited college or **Trade School**. No cash awards will be paid directly to the winners. Winners may re-apply in succeeding years for further awards. In no instance shall the scholarship awarded be more than actual college costs incurred by recipient.

PLEASE NOTE! All applications must be returned to Transit Supervisors Organization by **10AM on Thursday, December 28, 2023**, in order to be eligible for the scholarship. The drawing will be held virtually on Thursday, December 28, 2023, at 12:30 pm. Good luck!
