Scheduling Will Days - Estate planning consultations at the Union Headquarters, the job site or via Zoom, are designed to motivate the union membership to use their legal plan benefits and prompt them to complete their estate planning documents. On what we call “Will Days”, eligible members and their spouses have the opportunity to have a one-on-one consultation with an attorney.

Our attorneys will advise your members on how to complete their estate planning questionnaire and overcome the pitfall of: being out of sight, out of mind.
