

# Transport Workers Union (TWU) Local 106 Legal Services Plan

## ELIGIBILITY

You and your eligible dependents are covered by the Transport Workers Union (TWU) Local 106 (herein as the “Union”). The employee is frequently referred to as “the covered member” in this booklet.

Your “eligible dependents” are:

- \* Your legal spouse who resides with you.
- \* Your registered domestic partner.
- \* Your unmarried dependent children from birth to their nineteenth birthday.

This includes any child who:

- (1) normally resides in your household in a parent-child relationship; and
- (2) is legally dependent upon you for support and maintenance.

**\*Note:** Eligibility is extended to age 26 if your unmarried children are dependent upon you for support and enrolled as full-time students in an institution of higher education.

## CONTINUATION OF COVERAGE

If you become ineligible, specific representation in progress on your behalf shall be continued by the Legal Services Plan to the conclusion of a specific matter already in progress, at the legal fees stipulated in this Certificate for any case, item, matter, or service then being performed.



# Certificate of Coverage

## 1. Free Consultation Benefit

**Who is Eligible...** The covered member, spouse or domestic partner, and dependents.

**What is the Benefit...** The covered member, spouse, domestic partner, or dependent may get telephonic advice or in-office consultations. This benefit provides the covered member, spouse or domestic partner, and dependent with the opportunity to consult an attorney for three one-hour in-office sessions each calendar year concerning any new legal matter. In addition, the covered individual may consult with the Legal Service Plan attorneys an unlimited number of times over the telephone. The in-office consultations cannot be used as a credit toward any other service.

**How to Utilize the Benefit...** Contact the Legal Services Plan Attorney office at +1 (800) 832-5182 (for NY) or +1 (800) 292-8063 (for outside of NY).

## 2. 24-Hour Emergency Hotline Benefit

**Who is Eligible....** The covered member, spouse or domestic partner, and dependents.

**What is the Benefit...** If the covered member, spouse, domestic partner, or dependent is confronted with a situation that requires immediate legal advice, they may call the emergency hotline to talk to an attorney after regular business hours. This emergency service may only be used in situations that cannot wait until the next business day, such as arrest, accident, or assault.

**How to Utilize the Benefit....** Contact the Legal Services Plan Attorney office at +1 (800) 832-5182 (for NY) or +1 (800) 292-8063 (for outside of NY).

## 3. Free Document Review Benefit

**Who is Eligible...** The covered member, spouse or domestic partner, and dependents.

**What is the Benefit...** This benefit provides review and interpretation by an attorney of documents which directly involve the covered member, spouse, domestic partner, or dependent, such as guarantees, warranties, installment purchase agreements, loans, leases, and court papers.

**\*Exclusions & Limitations:** The following documents are not included in the Document Review Benefit:

- A. Tax Returns
- B. Work that other attorneys are preparing at the time of your Document Review appointment.
- C. Documents exceeding 15 pages in length.

The Document Review Benefit provides review and interpretation of documents: it does not involve representation by counsel unless such representation involves legal services covered by the Plan. If a covered matter is involved, the Plan will provide representation by an attorney in accordance with this Legal Services Plan.

## 4. Free Legal Letters Benefit

**Who is Eligible...** The covered member, spouse or domestic partner, and dependents.

**What is the Benefit...** Your Plan Attorney will write free legal letters on your behalf to resolve legal or consumer disputes before they become lawsuits. These letters are available regarding any covered legal matter. However, letters cannot be written in response to a pending lawsuit or regarding any personal injury claims, or in connection with any matter that, in the sole discretion of the attorney, constitutes an inappropriate, unethical, or frivolous matter.

**How to Utilize the Benefit...** Contact the Legal Services Plan Attorney office at +1 (800) 832-5182 (for NY) or +1 (800) 292-8063 (for outside of NY).

## 5. Free Last Will & Testament Benefit

**Who is Eligible...** Coverage is available to the member, spouse or domestic partner, and eligible dependents. Further, this benefit is extended to the members' parents, grandparents, parents-in-law and grandparents-in-law.

**What is the Benefit...** This benefit provides the covered individual with the opportunity to have a Last Will and Testament executed under the supervision of a Legal Benefits Plan Attorney. Advice regarding estate planning and potential strategies to reduce estate taxes are included.

**How to Utilize the Benefit...** To use the Last Will and Testament Benefit, you should complete the Confidential Will Questionnaire or contact the Legal Services Plan Attorney's office at +1 (800) 832-5182 (for NY) or +1 (800) 292-8063 (for outside of NY).

## 6. Free Health Care Proxy Benefit

**Who is Eligible...** Coverage is available to the member, spouse or domestic partner, and eligible dependents. Further, this benefit is extended to the members' parents, grandparents, parents-in-law and grandparents-in-law.

**What is the Benefit...** This benefit provides the covered individual with the opportunity to have a Health Care Proxy prepared and executed under the supervision of a Legal Services Plan Attorney.

**How to Utilize the Benefit...** To obtain the Health Care Proxy Benefit, complete the Confidential Will Questionnaire or contact the Legal Services Plan Attorney's office at +1 (800) 832-5182 (for NY) or +1 (800) 292-8063 (for outside of NY).

## 7. Free Living Will Benefit

**Who is Eligible...** Coverage is available to the member, spouse or domestic partner, and eligible dependents. Further, this benefit is extended to the members' parents, grandparents, parents-in-law and grandparents-in-law.

**What is the Benefit...** This benefit provides the covered individual with the opportunity to have a Living Will prepared and executed under the supervision of a Legal Services Plan Attorney.

**How to Utilize the Benefit...** To obtain the Living Will, complete the confidential Will Questionnaire or contact the Legal Services Plan Attorney's office at +1 (800) 832-5182 (for NY) or +1 (800) 292-8063 (for outside of NY).

## 8. Free Durable Power of Attorney Benefit

**Who is Eligible...** Coverage is available to the member, spouse or domestic partner, and eligible dependents. Further, this benefit is extended to the members' parents, grandparents, parents-in-law and grandparents-in-law.

**What is the Benefit...** This benefit provides the covered individual with the opportunity to have a Durable Power of Attorney prepared and executed under the supervision of a Legal Services Plan Attorney.

**How to Utilize the Benefit...** To obtain the Durable Power of Attorney Benefit, complete the Confidential Will Questionnaire or contact the Legal Services Plan Attorney's office at +1 (800) 832-5182 (for NY) or +1 (800) 292-8063 (for outside of NY).

## 9. Free Minor's Trust Benefit

**Who is Eligible...** Coverage is available to the member, spouse or domestic partner, and eligible dependents, and is extended to the members' parents, grandparents, parents-in-law and grandparents-in-law.

**What is the Benefit...** A "Minor's Trust" is a trust that leaves property to a younger person, but in the care of a trustee, until the young person reaches a designated age, (often age 25, 30, or 35). Trusts for younger individuals are usually set up by parents or grandparents who want to leave property to a young person, but also want to name a trusted adult to care for the property until the child is mature enough to inherit in their own name.

It is sometimes important to protect this younger person from themselves. Often a parent or grandparent may wish that the child finish college, and become financially responsible before the entire inheritance is distributed to that child. The minor's trust can also stagger multiple distributions from the estate geared to different ages of the child, thus potentially affording greater protection for the child's inheritance not being squandered or misused.

**How to Utilize the Benefit...** Contact the Legal Services Plan Attorney office to request an appointment at +1 (800) 832-5182 (for NY) or +1 (800) 292-8063 (for outside of NY).

## 10. Pooled Income Trust Benefit

**(No Legal Fee); (Medicaid Home Care, While Preserving Income); (NY Only)**

**Who is Eligible...** Coverage is available to the member, spouse or domestic partner, and eligible dependents, and is extended to the members' parents, grandparents, parents-in-law and grandparents-in-law who reside in the State of New York.

**What is the Benefit...** A pooled trust under Federal and New York statute, allows people with disabilities and older adults seeking long-term care services to protect their income in order to qualify financially or maintain eligibility for government benefits, such as Medicaid.

Pooled trusts give people with disabilities a way to obtain home-care benefits while utilizing their excess or unprotected income placed in the trust to pay for items and services not covered by Medicaid. This trust enables people with disabilities to utilize this portion of their income, which Medicaid would otherwise require be "spent down on medical needs", to pay for living expenses such as rent, utility bills, food, clothing, and other personal needs.

**How to Utilize the Benefit...** Contact the Legal Services Plan Attorney office to request an appointment at +1 (800) 832-5182 (for NY) or +1 (800) 292-8063 (for outside of NY).

## 11. Will Days

**Who is Eligible...** Coverage is available to the member, spouse or domestic partner, and eligible dependents. Further, this benefit is extended to the members' parents, grandparents, parents-in-law and grandparents-in-law.

**What is the Benefit...** We are prepared to conduct estate planning consultations at Union Headquarters, or via Zoom, designed to motivate the union membership to use their legal plan benefits and prompt them to complete their estate planning documents.

On what we call "Will Days", eligible members have the opportunity to have a one-on-one consultation with an attorney. This attorney will educate members on how to complete their estate planning questionnaire, and overcome the pitfall of: out of sight, out of mind. Estate planning documents are then mailed to the member for review. Then the member can sign up for a signing day at Union Headquarters, our offices or a local Law Office, wherein they will meet with the attorney again to ensure the documents are correctly executed. Statistical research has shown us that members of the legal plan who complete their Last Will and Testament are more apt to utilize other benefits provided by the legal plan and the Union than those who do not. As a result, retention rates are also quantitatively impacted.

## 12. Legal Plan Workshops Benefit

**Who is Eligible...** Coverage is available to the member, spouse or domestic partner, and eligible dependents, and is extended to the members' parents, grandparents, parents-in-law and grandparents-in-law.

**What is the Benefit...** We believe that together we can encourage utilization of the Legal Plan Benefits through workshops designed to educate union members regarding benefits that will enhance and enrich their lives. Our seminars are tailored to motivate membership to take advantage of their many legal plan benefits and prompt them to complete their estate planning documents.

This program will draw your members to Union Headquarters or other location, where they can socialize with other members, be inspired by their union and engage with issues that affect membership. This is another opportunity to reconnect with your more active members and, at the same time, advertise upcoming programs and events. Workshops, in general, educate members on why this and other union benefits are so valuable. This is a highly successful program.

## 13. Will & Estate Planning Preparation Webinar Benefit

**Who is Eligible...** Coverage is available to the member, spouse or domestic partner, and eligible dependents, and is extended to the members' parents, grandparents, parents-in-law and grandparents-in-law.

**What is the Benefit...** We believe that together we can encourage utilization through virtual workshops designed to educate union members regarding their Legal Plan benefits that will enhance and enrich their lives. Our webinars through Zoom are pre-consultation estate planning workshops tailored to motivate membership to take advantage of their legal plan and prompt them to complete their estate planning documents.

This program will draw your members to a virtual platform, where they can socialize with other members, be inspired by their union and engage with issues that affect membership. This is another opportunity to reconnect with your more active members and, at the same time, advertise upcoming programs and events. Webinars, in general, educate members on why this and other union benefits are so valuable. This is a highly successful program. Members will be given the opportunity to sign up in advance for an appointment via Zoom to meet with an attorney for FREE.

**How to Utilize the Benefit....** The Union leadership should contact the Legal Services Plan Attorney's office at +1 (800) 832-5182 (for NY) or +1 (800) 292-8063 (for outside of NY).

## 14. Elder Law Benefit

**Who is Eligible...** Coverage is available to the member, spouse or domestic partner, and eligible dependents, and is extended to the members' parents, grandparents, parents-in-law and grandparents-in-law.

**What is the Benefit...** Our Elder Law attorneys will consult with the covered member, spouse or domestic partner, eligible dependents, parents, grandparents, parents-in-law, and grandparents-in-law who reside in the State of New York to discuss asset preservation strategies. The first hour is free, and all subsequent time will be billed at a 20% reduction from the Elder Law attorneys' usual billing rate. Elder Law differs from Estate Planning which is covered at no cost in the Last Will and Testament paragraph herein. Elder Law focuses on asset transfers which will protect assets in the event of the need for nursing home care. Elder Law attorneys can advise on State law and assist in putting a health and estate plan in effect, which can maximize eligibility for coverage of nursing home and home care costs while preserving one's estate and assets. The attorneys who will provide the listed services concentrate their practice in the subject area of Elder Law, estate planning, wills, trusts, pre-nursing home planning, probate and conservatorship.

## 15. Guardianship Benefit

**Who is Eligible...** Any covered member.

**What is the Benefit...** Guardianship may be necessary when minors are entitled to a Will bequest or insurance proceeds. Parents of these minors may have to apply to the court for guardianship in order to properly invest such funds. Plan attorneys will represent the covered member in formal guardianship proceedings. The Plan attorney will prepare all petitions and supporting papers and will appear in court with the party in support of the guardianship, if required.

## 16. Patient and Caregiver Advocacy Benefit

**Who is Eligible...** Coverage is available to the member, their spouse or domestic partner, eligible dependents, and is extended to the member's parents, grandparents, parents-in-law and grandparents-in-law. These individuals will have access to an interdisciplinary team of healthcare professionals including nurses, geriatric social workers, rehabilitation and long-term care experts, as well as patient care advocates.

The team will support and guide you and your loved ones in times of uncertainty and during transitions of care. Having our healthcare experts work with you and your loved ones and coach you on how to navigate our healthcare system can be instrumental in lowering your stress level. Our goal is to ensure that you and your loved ones receive the best possible care while protecting the maximum amount of assets and safeguarding your legacy.

**What is the Benefit...** Supporting our clients, and their caregivers, is crucial to the well-being of all those involved. The healthcare system is complex and often overwhelming. ## 17. Veterans Benefit

**Who is Eligible...** The covered member, spouse or domestic partner, and dependents.

**What is the Benefit...** We will assist the covered individual with applying for the Veterans Benefit, Aid and Attendance, which provides extra income for a veteran who requires medical care. We would extend this benefit to their spouse, domestic partner, parents, and parents-in-law.

**How to Utilize the Benefit...** To use the Veterans Benefit, contact the Legal Services Plan Attorney Office to request an appointment at +1 (800) 832-5182 (for NY) or +1 (800) 292-8063 (for outside of NY).

## 18. Student Loan Reduction Assistance Benefit

**Who is Eligible...** The covered member, spouse or domestic partner, and dependents.

**What is the Benefit...** We will help student loan borrowers with the repayment process. Managing their student loans and understanding the repayment options can be confusing and overwhelming, especially when you're getting unclear or conflicting information from your loan servicer. We can help.

## 22. Traffic Matter Benefit

**Who is Eligible...** The covered member.

**What is the Benefit...** This benefit provides Legal Representation for the covered member with a consultation in matters concerning any traffic violation and representation in court in all instances where, in connection with the operation of a motor vehicle, a traffic ticket has been issued. The benefit is limited to moving violations within the New York Tristate area, where a conviction will result in points on license.

Representation in court under this benefit is available once in a twelve (12) month period beginning the day you first consult with the Plan attorneys concerning a traffic-related matter. This benefit includes a trial if necessary.

## 30. Criminal Defense Benefit

Representation is available from the Plan attorneys at \$285.00 per hour. ## Contingent Fee Matters

### 36. Personal Injury Benefit

**Who is Eligible...** The covered member, spouse or domestic partner, and dependents.

**What is the Benefit...** Personal Injury cases are handled on a contingency fee basis. That means that the attorney fees are a percentage of the recovery rather than at an hourly rate. If there is no recovery, you don't pay any legal fees. The law sets the percentage of the contingent fees and your plan has offered a reduction of that fee.

In the event that the covered member, their spouse or domestic partner, or their dependent is injured in a car accident, slip and fall accident, dog bite, product liability, premises accident, etc., your Plan Attorney will reduce the standard contingency fees approved by the court of the applicable state as follows:

Twenty percent (20%) reduction of the contingency fee if the case is settled prior to examination before trial.

Ten percent (10%) reduction of the contingency fee if the case is settled after an examination before trial or is tried to a conclusion.

This reduction can save an injured victim many thousands of dollars.

Legal representation is available for medical or other professional malpractice. However, it is not possible to reduce the fees for those matters.

### 37. Estate Administration Benefit

**Who is Eligible...** Coverage is available to the member, spouse or domestic partner, and eligible dependents, and is extended to the members' parents, grandparents, parents-in-law and grandparents-in-law.

**What is the Benefit...** Legal Representation in an uncontested probate of a Last Will and Testament or an uncontested estate administration proceeding in the Surrogate's Court in the absence of a Will. The benefit allowance is a twenty-five (25%) percent reduction in the percentage contingencies used to calculate the statutory fiduciary commissions as outlined in the New York State Surrogate's Court Procedure Act, Section 2307 or New Jersey Surrogates Act, section 54: 34-5C. This includes the filing of Federal and State estate tax returns. Legal fees do not include court filing fees and expenses or disbursements that are chargeable to the client.

## 38. Stockbroker Arbitration Benefit

**Who is Eligible...** The covered member, spouse or domestic partner, and dependents.

**What is the Benefit...** Elder financial abuse is on the rise and is expected to impact an increasing number of families across America over the next decade. Financial abuse cases arising out of Investment Fraud, Investment loss, Financial Adviser Misconduct, Account Churning, are accepted on a contingent fee basis by a participating referral attorney with a Ten percent (10%) reduction from the standard contingency fee approved by the court of the applicable state.

## 39. Tax Grievance Benefit

**Who is Eligible...** The covered member, spouse or domestic partner, and dependents.

**What is the Benefit...** This benefit provides counseling and assistance with filing a Tax Grievance in certain counties in New York State. A Legal Plan real estate tax attorney can challenge property tax assessments on residential and commercial properties located in Nassau, Suffolk, Rockland, Putnam, and Orange counties and reduce homeowner's or business owner's real estate taxes, if we can prove that the property has been overvalued by the county.

A Property Tax Grievance allows your current assessment to be reviewed by the Assessor to see if a reduction is warranted. If the Assessor does not reduce your assessment, an appeal can be filed to have an impartial hearing officer determine if your house is overvalued for tax purposes. Property taxes can seem very complicated and like income taxes, your property taxes should be reviewed annually for the possibility of a reduction.

A Legal Plan attorney will analyze each home on a case-by-case basis to determine the potential for a reduction. Whether there is merit to an appeal is based on many factors including sales of comparable properties and factors unique to your home that can affect the potential market value used to review your assessment. If the attorney can prove your home is worth less than the assessed value, we will accept your grievance and aggressively seek to reduce your property taxes to the lowest amount allowed by law.

There is absolutely no fee if there is no tax reduction. Our fee is reduced from the industry standard of 50% of the property tax reduction to 38%, which is due after the official reduction notification is received. It's a flat fee that you pay only once. If we do not succeed, you pay nothing. It's important to note: grieving your property taxes will never result in your taxes going up. \*If a "Small Claims Assessment Review" (SCAR) petition is filed, a \$30 court-filing fee may apply.

## General Exclusions

1. All legal services provided by the Legal Services Plan have been specifically stated and described. Any legal service that has not been so described can be considered excluded from the Legal Services Plan of Benefits.
2. However, in order to guide the member in his utilization of the Legal Services Plan Benefit package, this section lists specifically, but without limitation, particular exclusions of the Plan.
3. Any controversy, dispute or proceeding with or against the employer or the employer's agent or officers including but not limited to claims for workers compensation, disability insurance or unemployment compensation.
4. Any controversy, dispute or proceeding directed against the Union or any of their affiliated bodies, e.g. the benefit plans, or any of the officers, agents or attorneys of the Union or its affiliated bodies or any corporations, organizations or entities with which the Welfare Fund has contractual relationships.
5. Any controversy, action or proceeding in which the Legal Services Plan would be prohibited from defraying the cost of legal services by any provision of law.
6. Any controversy, action or proceeding in which representation on a contingent fee basis is normally and customarily available or where the fee is payable by virtue of statute or by order of Court, unless otherwise stated.
7. Class action or interventions or amicus curiae activities. Two or more parties may not pool or combine their benefits for the purpose of making a claim in which they have a mutual interest.
8. Any matter concerning the payment of income tax including, but not limited to, preparation or filing of income tax returns.
9. The Plan will not pay the claims for services or advice when such activity involves application of the same service or advice previously obtained in connection with the same problem and previously claimed for under the Plan.
10. Appellate matters.
11. Services, fees or expenses in connection with any business venture or other matters in which, for Federal Income Tax purposes, the cost of the legal services would normally constitute a business expense or capital investment.
12. The Plan will not pay court costs and/or filing fees nor will the Plan pay fines or penalties in any amount.
13. Any controversy, action, proceeding or dispute which legal services are available through insurance or through any governmental agency or attorney (Federal, State or Local).
14. Any controversy, dispute or proceeding in which the member retained an attorney or represented himself/herself prior to contacting the Legal Plan.
15. Matters where an eligible participant or his dependent is an adverse party in an action involving another employee or his dependent.
16. Any matter that in the opinion of the attorney is lacking sufficient merit to warrant pursuit.
17. Any matter not specifically provided herein is excluded from coverage.

## Grievance and Arbitration

In the event any controversy or complaint arises in connection with the terms and procedures contained in this Certificate involving the Legal Plan, a Participating Referral Attorney, a Covered Member and Dependent, or any combination thereof, the following procedures should be followed.

**FIRST:** Fully exhaust all possibilities of resolving the dispute with the other party or parties involved. When all such possibilities have been exhausted, Covered Member or Dependent may then:

**SECOND:** Notify the Grievance Department in writing, as to the nature of the dispute and all of the relevant particulars. In the event the Grievance Department of the Law Firm is unable to effectuate a satisfactory resolution, the Covered Member may then:

**THIRD:** Appeal to the office of the Special Arbitrator for its help toward resolving the complaint or controversy by writing to Special Arbitrator. The arbitrator shall have the power to decide any dispute among the parties and individuals involved concerning the application or interpretation of the terms of this Certificate and the performance thereunder.

## Appeals to the Board of Trustees

The Board of Trustees adopts rules and regulations for the payment of benefits and all provisions in this booklet are subject to such rules and regulations and to the agreement and declaration of trust, which established the Plan and governs its actions.

A covered member may request a review of action taken by the Plan Office by submitting an appeal, in writing, to the Board of Trustees within 60 days after the action of the Plan.
